



## **GRANGE INFANT SCHOOL** **PROTECTION OF BIOMETRIC DATA POLICY**

Grange Infant School does not use any biometric information about pupils for the purposes of using automated biometric recognition systems, nor is there any plan to install them.

### **Key Points**

The following guidance is the non-statutory advice from the Department of Education:

Schools that use pupils' biometric data must treat the data collected with appropriate care and must comply with the data protection principles as set out in the General Data Protection Regulations (GDPR 2018).

Where the data is to be used as part of an automated biometric recognition system, schools must also comply with the additional requirements in sections 26 to 28 of the Protection of Freedoms Act 2012.

Schools must ensure that each parent of a child is notified of the school's intention to use the child's biometric data as part of an automated biometric recognition system.

The written consent of at least one parent/carer must be obtained before the data is taken from the child and used i.e., 'processed'. This applies to all pupils in schools and colleges under the age of 18. In no circumstances can a child's biometric data be processed without written consent.

Schools must not process the biometric data of a pupil (under 18 years of age) where:

- The child (whether verbally or non-verbally) objects or refuses to participate in the processing of their biometric data;
- No parent/carer has consented in writing to the processing; or
- A parent/carer has objected in writing to such processing, even if another parent has given written consent.

Schools must provide reasonable alternative means of accessing services for those pupils who will not be using an automated biometric recognition system.

### **What is biometric data?**

Biometric data means personal data resulting from specific technical processing relating to an individual's physical, physiological or behavioural characteristics of a person, which allows or confirms the identification of that person; this can include their fingerprints, facial shape, retina and iris patterns, and hand measurements.

All biometric information is considered to be personal data as defined by the GDPR 2018; this means that it must be obtained, used and stored in accordance with that Regulation. Further details can be found in our Data Protection and GDPR policies.

The Protection of Freedoms Act 2012 includes provisions which relate to the use of biometric data in schools when used as part of an automated biometric recognition system. These provisions are in addition to the requirements of the GDPR 2018.

**What is an automated biometric recognition system?**

An automated biometric recognition system uses technology which measures an individual's physical or behavioural characteristics by using equipment that operates 'automatically' (i.e. electronically). Information from the individual is automatically compared with biometric information stored in the system to see if there is a match in order to recognise or identify the individual.

Biometric recognition systems can use many kinds of physical or behavioral characteristics such as those listed in the paragraph above.

**What does processing data mean?**

'Processing' of biometric information includes obtaining, recording or holding the data or carrying out any operation or set of operations on the data including (but not limited to) disclosing it, deleting it, organising it or altering it. An automated biometric recognition system processes data when:

- a) Recording pupils' biometric data, for example, taking measurements from a fingerprint via a fingerprint scanner;
- b) Storing pupils' biometric information on a database system; or
- c) Using that data as part of an electronic process, for example, by comparing it with biometric information stored on a database in order to identify or recognise pupils.
